## Letter from the President

Dear Colleagues,

The 116th Annual Meeting of the Dante Society of America will be held on Saturday, May 2, from 2:00 to 4:00 p.m. (reception to follow) at Sever Hall 202 on the Harvard University campus, in Cambridge, Massachusetts. After our usual brief business meeting, Rachel Jacoff, Wellesley College, will speak on "Dante and the Legend(s) of Saint John." At the Dante Society's MLA session in San Francisco this December our speaker will be Steven Botterill, University of California, Berkeley. Professor Botterill will speak on "Dante and the Language of Community."

I am pleased to announce that the Dante Society will hold a Dante 2000 Conference in the spring of the year 2000. Please mark April 7-9 (Friday-Sunday) of the year 2000 on your calendars and be prepared for a visionary, if not conversional, experience. We will hold a "New Technologies" demo/exhibit and have an exhibition space that will display current translations and illustrations of the *Commedia*. We plan to feature sessions on "Dante and Gender," "Science and Philosophy," "Material Culture," "Reception and Cultural Studies," "The Body," "Eschatology and Visions," "Dante and Ovid," and "Eros and Mysticism."

Accompanying this mailing you will find an enclosed ballot containing the slate of candidates prepared by the Nominating

Committee, as provided by our by-laws. Kindly mark your ballot, seal it in the envelope provided, and return it, together with the proxy statement, in time to have it included in the vote count on April 30. The returning members of the
